WORKSHOPS

WORKSHOP SESSION I (SUNDAY)

WORKSHOP 1: A CALL FOR SUSTAINABLE, EQUITABLE AND TRANSPARENT INFRASTRUCTURE INVESTMENT: THE ROLE OF THE G20

THIS MULTI-STAKEHOLDER SESSION WILL BRING TOGETHER EXPERTS WITH IN-DEPTH KNOWLEDGE OF MANY DISCIPLINES (SUCH AS INFRASTRUCTURE, INVESTMENT, ANTI-CORRUPTION, HUMAN RIGHTS, EQUALITY, CLIMATE) AND A STRONG PUBLIC VOICE OF PARTICIPANTS TO DEBATE AND PROVIDE SUGGESTIONS FOR G20 ACTION. IT WILL DEMONSTRATE HOW TO BUILD ON CURRENT EFFORTS TO ENSURE THAT THE G20'S PARADIGM FOR INFRASTRUCTURE WILL PROMOTE CORRUPTION-FREE PROJECTS WHICH RESPECT HUMAN RIGHTS AND ENVIRONMENTAL LIMITS. THE FORMAT WILL INCLUDE PRESENTATIONS AND AN ACTIVE Q&A SESSION WITH THE AUDIENCE.

WORKSHOP 2: RESOLUTION OF THE NEXT GLOBAL DEBT CRISIS: A GAP ON THE G20 AGENDA?

IN THE WORKSHOP, WE WANT TO DISCUSS, HOW THE NEXT CRISIS WILL EMERGE AND WHAT RISKS PROGRAMS LIKE THE G20'S "COMPACT WITH AFRICA", WHICH EMPHASIZES ENHANCED PRIVATE CAPITAL EXPORTS, WILL IMPLY. WE WILL ANALYSE THE OUTCOMES OF THE G20 FINANCE MINISTERS' MEETING REGARDING DEBT CRISIS PREVENTION AND RESOLUTION AND DEVELOP STRATEGIES FORWARD, ALSO WITH THE VIEW TO THE NEXT G20 PRESIDENCY IN ARGENTINA.

WORKSHOP 3: WOMEN'S ECONOMIC EMPOWERMENT- CHALLENGES AND PERSPECTIVES FOR G20

THE WORKSHOP WANTS AN OPEN DISCUSSION ON THE CHALLENGES AND DIFFERENT PERSPECTIVES OF WOMEN'S ECONOMIC EMPOWERMENT. SHORT STATEMENTS ON THE DEFINITION AND SITUATION OF ECONOMIC EMPOWERMENT AS A MORE THEORETICAL APPROACH, ON GENDER BUDGETING AS A STRATEGY AND DIFFERENT INPUTS FROM KENIA AND ARGENTINA AS A PRACTICAL APPROACH WILL FACILITATE THE DISCUSSION. ADDITIONALLY, THE GROUP WILL BE SPLIT UP IN LITTLE MUMBLING GROUPS TO PROMOTE AND SUPPORT THE DIRECT EXCHANGE BETWEEN THE PARTICIPANTS.

WORKSHOP 4: HUMAN RIGHTS TO WATER AND SANITATION AT THE CORE OF THE SDGS

PRESENTATIONS AND DEBATE OF HOW THE HUMAN RIGHTS TO WATER AND SANITATION CAN FULFIL AN IMPORTANT ENABLING ROLE AND ARE IMPERATIVE TO ADVANCE SDGS AND SUSTAINABLE DEVELOPMENT. THREE EXAMPLES WILL BE GIVEN AND DISCUSSION SHOULD LEAD TO ACTIONS AND IDEAS TO PROMOTE A HUMAN RIGHTS-BASED APPROACH TO SUSTAINABLE DEVELOPMENT AND THE G20 AGENDA.

WORKSHOP 5: POLICY SOLUTIONS FOR REFUGEE INTEGRATION – BEST PRACTICES FROM HOST COUNTRIES

THIS PANEL DISCUSSION WILL BRING TOGETHER REPRESENTATIVES FROM ACADEMIC INSTITUTIONS AND CIVIL SOCIETY ORGANIZATIONS TO REFLECT ON THE RELATIONSHIP BETWEEN REFUGEE INTEGRATION AND INTERNATIONAL RESPONSIBILITY SHARING IN THE CONTEXT OF DURABLE SOLUTION, FROM THE PERSPECTIVES OF SOME OF THE WORLD'S TOP REFUGEE-HOSTING

COUNTRIES. DRAWING ON THE EXPERIENCES OF REFUGEE INTEGRATION IN TURKEY, LEBANON, JORDAN AND UGANDA, THIS SESSION AIMS TO SHINE A LIGHT ON SOME OF THE EXISTING POLICY AND PROGRAMMATIC INTERVENTIONS THAT ARE SUPPORTING REFUGEE INTEGRATION IN THESE CONTEXTS, AND TO CONTRIBUTE TO A BETTER UNDERSTANDING OF THE INVALUABLE CONTRIBUTIONS OF REFUGEE-HOSTING COUNTRIES TO MEETING REFUGEES' NEEDS.

WORKSHOP 6: CARBON PRICING & FOSSIL FUEL SUBSIDY REFORM IN THE G20

THE WORKSHOP ON FOSSIL FUEL SUBSIDIES AND CARBON PRICING SEEKS TO SHED LIGHT ON WHAT IS HAPPENING IN DIFFERENT COUNTRIES AND REGIONS IN REGARD TO CARBON PRICING MEASURES AND TOOLS, AND HOW THEY CAN RE-ENFORCE OUR EFFORTS TO ADDRESS FOSSIL FUEL SUBSIDIES. THE DISCUSSION WILL TAKE A BROAD AND INFORMATIVE APPROACH THAT WILL BUILD CAPACITY AMONG CSOs INTERESTED IN THE ISSUES, AND DISCUSS HOW TO COMMUNICATE THE TOPIC OF CARBON PRICING TO A WIDER AUDIENCE.

WORKSHOP 7: DELIVERING HEALTH FOR ALL: RESILIENT HEALTH SYSTEMS FOR SUSTAINABLE DEVELOPMENT

THIS SESSION WILL EXAMINE SOME OF THE MANY DIFFERENT DIMENSIONS OF BUILDING STRONG, RESILIENT AND RESPONSIVE HEALTH SYSTEMS, WHICH ARE CRUCIAL IF UNIVERSAL HEALTH COVERAGE IN RAPIDLY SHIFTING GLOBAL CONTEXTS IS TO BE ACHIEVED. THE WORKSHOP WILL ADDRESS THREE MAIN AREAS: THE CHALLENGES POSED TO HEALTH SYSTEMS BY GLOBAL PHENOMENA, GOOD PRACTICE INTERVENTIONS TO PROVIDE COMPREHENSIVE CARE FOR A RANGE OF DISEASE AREAS AND THE ROLE OF UN AGENCIES AND INSTITUTIONS IN HEALTH SYSTEMS STRENGTHENING, IN TERMS OF FINANCING AND GLOBAL COORDINATION.

WORKSHOP 8: SOCIAL PROTECTION & FISCAL RESPONSIBILITY

THIS WORKSHOP WILL PRESENT A SERIES OF PUBLIC POLICY RECOMMENDATIONS TO GENERATE FAIRER AND MORE EFFECTIVE DOMESTIC FISCAL AND INTERNATIONAL SUPPORT SYSTEMS TO ASSURE ADEQUATE FINANCING FOR SPFs IN BAD AS WELL AS GOOD ECONOMIC TIMES. IT WILL ALSO UPDATE ON INTERNATIONAL PROGRESS AND CHALLENGES IN ADVANCING INTERNATIONAL SUPPORT FOR SPFs.

WORKSHOP 9: AN INTRODUCTION TO THE G20

THE WORKSHOP WILL PROVIDE AN OVERVIEW OF THE STRUCTURE, ORGANIZATION AND PROCESS OF G20 DECISION MAKING AND HOW TO BEST INFLUENCE THE OUTCOMES. TOPICS INCLUDE: COUNTRY MAKEUP OF THE G20, G20 ISSUE TRACKS AND WORKING GROUPS, INVOLVEMENT OF INTERNATIONAL ORGANIZATIONS, G20 ENGAGEMENT GROUPS, G20 ADVOCACY STRATEGIES, G20 MEDIA WORK, EXAMPLES OF ADVOCACY WORK: G20 ANTI-CORRUPTION WORKING GROUP/WOMEN'S ECONOMIC EMPOWERMENT, 2018 G20 IN ARGENTINA

WORKSHOPS

WORKSHOP SESSION II (SUNDAY)

WORKSHOP 1: CHINA'S CLIMATE AND INFRASTRUCTURE POLICIES AND ENVIRONMENTAL AND SOCIAL JUSTICE

THIS WORKSHOP WILL FOCUS ON THE COOPERATION BETWEEN CHINESE AND EUROPEAN NGOS IN FIELDS RELEVANT TO G 20 ADVOCACY. THE SESSION IS DIVIDED IN TWO PARTS. THE SESSION WILL FOCUS ON PREVIOUS EXPERIENCES WITH THE G20 PROCESS. WE WILL TALK ABOUT STRUCTURES TO FOSTER ACTIVE ENGAGEMENT DURING THE NEXT PRESIDENCIES. PART TWO IS TOUCHING ON RELEVANT FIELDS IN WHICH CHINESE AND EUROPEAN NGOS SHOULD WORK TOGETHER:

WORKSHOP 2: WAYS FORWARD PROMOTING AN AMBITIOUS CLIMATE AND ENERGY AGENDA WITHIN THE G20

THIS WORKSHOP WILL REFLECT ON THE OPTIONS FOR CIVIL SOCIETY TO WORK WITHIN AND MOBILIZE AROUND G20 TOWARDS AN AMBITIOUS IMPLEMENTATION OF THE PARIS AGREEMENT, FOSTERING A JUST TRANSITION. WE WILL LOOK AT THE CURRENT STATE OF AFFAIRS WITH THE G20 ENERGY AND CLIMATE ACTION PLAN COMPARED TO OUR KEY ASKS, EXCHANGE VIEWS BETWEEN REPRESENTATIVES FROM DIFFERENT COUNTRIES AND ORGANIZATIONS AND IDENTIFY PRIORITY AREAS OF FUTURE WORK.

WORKSHOP 3: ENVIRONMENTAL PROTECTION ON GLOBAL, NATIONAL AND LOCAL LEVEL- CHANCES AND LIMITS OF INFLUENCE ON INTERNATIONAL INSTITUTIONS

ENVIRONMENTAL POLICY IS IN AN AMBIVALENT SITUATION REGARDING INTERNATIONAL POLITICS. ON ONE HAND MANY OF THE DECISIONS ON INTERNATIONAL LEVEL INVOLVE CONSIDERABLE DISADVANTAGES FOR CLIMATE, NATURE AND ENVIRONMENTAL PROTECTION. ON THE OTHER HAND IT IS IMPORTANT TO NOTE THAT ISSUES SUCH AS AIR POLLUTION, CLIMATE PROTECTION OR EFFECTIVE PROTECTION OF MIGRATORY SPECIES CAN ONLY BE SUCCESSFUL IF MEASURES ARE TAKEN ON THE HIGHEST POSSIBLE LEVEL AND IF ENVIRONMENTAL REGULATIONS ARE AGREED GLOBALLY.

WORKSHOP 4: GLOBAL HEALTH RESEARCH & DEVELOPMENT: A NATIONAL, G20 AND GLOBAL PRIORITY! – THE ROAD TO ARGENTINA

TODAY'S WORLD SEES RISING ALARM REGARDING THE INABILITY TO RESPOND TO EMERGING PANDEMICS AND ANTIMICROBIAL RESISTANCE (AMR). DRUG RESISTANCE IS A THREAT TO PUBLIC HEALTH, GROWTH AND ECONOMIC STABILITY THAT REQUIRES IMMEDIATE ACTION. NEW TOOLS ARE NEEDED BUT THE CURRENT COMMERCIAL RESEARCH AND DEVELOPMENT SYSTEM IS FAILING TO PROVIDE THEM. IN HAMBURG, LEADERS WILL BE DISCUSSING – AND HOPEFULLY TAKING – MUCH NEEDED G20 ACTION ON AMR. THIS WORKSHOP WILL PROVIDE AN OPPORTUNITY FOR CIVIL SOCIETY AND OTHER GROUPS WORKING ON HEALTH TO DISCUSS THE SUCCESSES AND CHALLENGES OF ENGAGING MEANINGFULLY IN THE G20 PROCESS.

WORKSHOP 5: THE DIGITALISATION AGENDA OF THE G20: WHY CIVIL SOCIETY SHOULD CARE, TOWARDS ARGENTINA

THE DIGITALISATION MINISTERIAL IN DUSSELDORF HAS AGREED TO CONTINUE THE WORK OF THE G20 ON DIGITALISATION DURING THE ARGENTINA PRESIDENCY. WHILE THE TOPIC WAS HIGH IN THE GERMAN PRESIDENCY, THE NOVELTY OF THE TOPIC LIMITED THE CAPACITY OF CIVIL SOCIETY TO CONTRIBUTE. THE FIRST PART OF THE WORKSHOP IS ORIENTED TO IMPROVE THE UNDERSTANDING OF THE C20 COMMUNITY ABOUT THE RELEVANCE OF DIGITALISATION IN EVERYONE'S LIFE. THE SECOND PART WILL FOCUS ON EVALUATING THE CURRENT OUTCOMES AND TO START SHAPING THE CIVIL SOCIETY AGENDA TOWARDS THE G20 ARGENTINA PRESIDENCY.

WORKSHOP 6: CONTINUITY AND CHANGE AT THE G-20

BASED ON A GROUP DISCUSSION FORMAT THIS WORKSHOP AIMS TO REFLECT ON RECENT TRANSFORMATIONS IN THE POLITICAL SPHERE OF KEY G-20 COUNTRIES, AND THEIR FORESEEN IMPLICATIONS, TO CONSIDER CSOs' ACTIONS TOWARDS SHIELDING CERTAIN POLICY ACHIEVEMENTS (IE SDGS, ENVIRONMENTAL PROVISIONS) WHILE PUSHING FOR OTHER ONES (FREE VS FAIR TRADE) BY PROVIDING SUBSTANCE AND CONTEXT.

WORKSHOP 7: BUILDING A C20 MULTIYEAR STRATEGY

THE EFFECTIVENESS OF C20 HAS BEEN PROGRESSIVELY RECOGNIZED TO BE LIMITED BY ITS YEAR-BY-YEAR APPROACH TO HOW IT ORGANIZES, NOT ADEQUATELY BUILDING ON PRIOR YEARS AND THE CROSS-CUTTING NATURE OF MANY OF THE THEMATIC AREAS REGARDLESS OF THE SPECIFIC PRIORITIES OF THE G20 PRESIDENCY. FURTHERMORE, NOT ONLY IN THE CONTEXT OF THE G20, BUT GLOBALLY, CIVIL SOCIETY IS FINDING THAT ITS SPACE TO OPERATE IS SHRINKING. THE SESSION WILL AIM TO ADVANCE POSITIONS REFLECTED IN THE CLOSING COMMENTS BY SEVERAL PREVIOUS C20 CHAIRPERSONS.

WORKSHOP 8: G20-COMPACTS WITH AFRICA

THE C20 SHALL PURSUE THE FORMING OF OPINION AND ARTICULATE CRITICAL POSITIONS TOWARDS THE PLANNED "G20-COMPACT WITH AFRICA". INITIALLY, THERE WOULD BE TWO INPUTS OF TWO PREVIOUS ACTIVITIES. FIRSTLY, A SHORT PRESENTATION OF RESULTS OF AN OPINIONFORMING PROCESS BY THE AFRICAN COMMUNITY OF HAMBURG AT THEIR AFRICA-DAYS. SECONDLY, A SHORT PRESENTATION OF PROTESTS AND THE OUTCOME OF THE OFFICIAL G20-CONFERENCE ON "COMPACTS WITH AFRICA") IN BERLIN.

WORKSHOP 9: CAN THE POLLUTER PAYS PRINCIPLE HELP TO SPEED UP THE TRANSFORMATION TO A SUSTAINABLE WORLD

WHILE IT IS PERFECTLY NORMAL THAT I HAVE TO PAY COMPENSATION TO MY NEIGHBOR IF I DAMAGE HIS CAR, THIS PRINCIPLE IS HARDLY IN USE FOR THE COMMONS. THE "COST SHIFTING PRINCIPLE" IS THE CORE BUSINESS MODEL OF MANY COMPANIES, THE COST BEING SHIFTED TO THE LOCAL COMMUNITY, TO OTHER COUNTRIES, OR TO FUTURE GENERATIONS. MOST PEOPLE WILL FIND THIS UNFAIR. THIS FEELING MIGHT BE A WAY TO GAIN GENERAL SUPPORT FOR THE INTRODUCTION OF THE POLLUTER PAYS PRINCIPLE WHICH IS URGENTLY NEEDED IN ORDER TO STAY WITHIN THE PLANETARY BOUNDARIES.

SUSTAINABILITY WORKING GROUP

INVESTMENT WORKING GROUP

THIS WORKSHOP WILL BRING TOGETHER ACTORS FROM CIVIL SOCIETY, LABOR, BUSINESS, AND GOVERNMENT TO DISCUSS THE IMPORTANCE OF DUE DILIGENCE AND TRANSPARENCY IN IDENTIFYING, PREVENTING, MITIGATING, TRACKING AND COMMUNICATING POSSIBLE HUMAN RIGHTS OR LABOR RIGHTS VIOLATIONS, CORRUPTION, AND ADVERSE ENVIRONMENTAL IMPACTS THROUGHOUT SUPPLY CHAINS.

HEALTH WORKING GROUP

THIS WORKSHOP WILL FOCUS ON INNOVATIVE INITIATIVES AND MECHANISMS THAT HAVE DRIVEN GLOBAL HEALTH SUCCESSES. A PARTICULAR FOCUS WILL BE PLACED ON ORGANIZATIONS THAT WORK MULTI-SECTORALLY. WE WILL LOOK AT HOW DIFFERENT SECTORS CAN ENGAGE TO ENSURE THAT THE G20 GLOBAL HEALTH AGENDA AND POLICIES ACHIEVE RESULTS AT SCALE GLOBALLY, USING THE CASE OF PANDEMIC PREPAREDNESS AND VACCINE DEVELOPMENT.

SESSION 4: HOW DOES THE G20 DEVELOPMENT WORKING GROUP CONTRIBUTE TO ACHIEVING GENDER EQUALITY AND AGENDA 2030 IMPLEMENTATION?

INEQUALITY WORKING GROUP

ALL UN (AND G20) MEMBER STATES HAVE COMMITTED THEMSELVES TO THE SUSTAINABLE DEVELOPMENT GOALS OF THE AGENDA 2030. IN 2016, THE G20 ISSUED A G20 ACTION PLAN ON

AGRICULTURE WORKING GROUP

BY DISCUSSING EXPERIENCES FROM BOTH G20 (INDIA, GERMANY) AND NON-G20 COUNTRIES (BURKINA FASO, ETHIOPIA) THE WORKSHOP AIMS TO LOOK AT THE IMPACT OF G20 POLICIES ON FOOD AND NUTRITION SECURITY WORLDWIDE. FROM THE HOST COUNTRY'S SIDE, BOTH MINISTRIES RESPONSIBLE FOR AGRICULTURE AND FOOD SECURITY POLICIES WILL PRESENT THEIR ASSESSMENT OF THIS YEAR'S G20 DELIBERATIONS UNDER THE GERMAN PRESIDENCY.

FINANCE WORKING GROUP

THE G20'S COMPACT WITH AFRICA IS INTENDED TO IMPROVE AFRICA'S ECONOMIC SITUATION. WHILE THIS AIM IS RIGHT AND SOME INITIATIVES INCLUDED IN THE REPORT BY AFRICAN DEVELOPMENT BANK, IMF AND WORLD BANK ARE USEFUL, OTHER INITIATIVES WOULD PROBABLY NOT BRING SUSTAINABLE DEVELOPMENT BUT THE OPPOSITE. THIS IS PARTICULARLY LIKELY FOR THE USE OF PUBLIC PRIVATE PARTNERSHIPS FOR IMPORTANT INFRASTRUCTURES AND EXTENSIVE INVESTOR PROTECTION. ON THE OTHER HAND, ILLICIT FINANCIAL FLOWS AND DEBT PROBLEMS ARE NOT SUFFICIENTLY ADDRESSED, AS WELL AS HARMFUL EFFECTS ON PEOPLE AND THE ENVIRONMENT.

HE HEADS THE MANILA-BASED POLICY GROUP INSTITUTE FOR CLIMATE AND SUSTAINABLE CITIES (ICSC) AND WAS SENIOR ADVISOR TO THE PHILIPPINE PRESIDENCY OF THE CLIMATE VULNERABLE FORUM (DECEMBER 2014 TO AUGUST 2016), THE V20 GROUP OF FINANCE MINISTERS (OCTOBER 2015 TO AUGUST 2016) AND AN ADVISOR TO THE PHILIPPINE DELEGATION TO THE UNFCCC FOR SEVERAL YEARS. HE IS CURRENTLY TECHNICAL ADVISOR TO THE CVF SECRETARIAT.



GEORG JANBEN HAS BEEN ACTIVE FOR DECADES TO IMPROVE THE SITUATION OF FARMERS IN GERMANY. IN 1982 HE INITIATED THE ORGANISATION ARBEITSGEMEINSCHAFT BÄUERLICHE LANDWIRTSCHAFT (VIA CAMPESINA GERMANY) AND BECAME EXECUTIVE DIRECTOR IN 1985. HE IS DEDICATED TO GIVING FARMERS A VOICE AND WORKING TOWARDS A SOCIALLY AND ENVIRONMENTALLY SUSTAINABLE FUTURE OF FARMING.

RACHAEL CROCKETT IS THE TUBERCULOSIS POLICY ADVOCACY OFFICER AT RESULTS UK, AN INTERNATIONAL NGO THAT USES ADVOCACY AND CAMPAIGNING TO BRING ABOUT THE END OF EXTREME POVERTY. RACHAEL LEADS RUK'S POLICY ADVOCACY WORK ON TUBERCULOSIS, RESEARCH AND DEVELOPMENT, TB-HIV AND THE GLOBAL FUND TO FIGHT AIDS, TUBERCULOSIS AND MALARIA. SHE HAS A SPECIAL INTEREST IN THE ROLE CIVIL SOCIETY CAN PLAY IN ENDING THE EPIDEMIC AND ASSISTS IN THE COORDINATION OF THE TB EUROPE COALITION, A NETWORK DEDICATED TO SEEING THE END OF TB. RACHAEL IS THE INTERNATIONAL CO-CHAIR OF THE C20 WORKING GROUP OF HEALTH.

ANGELA MERKEL WAS BORN IN HAMBURG ON 17 JULY 1954. AFTER AN ACADEMIC CAREER IN

PHYSICS (DOCTORATE THESIS ON CALCULATING THE VELOCITY CONSTANTS FOR SIMPLE HYDROCARBON REACTIONS) SHE JOINED “DEMOKRATISCHER AUFBRUCH” (DEMOCRATIC NEW BEGINNING) IN 1989. SHE HAS BEEN A MEMBER OF THE CDU (CHRISTIAN DEMOCRATIC UNION OF GERMANY) AND A MEMBER OF THE GERMAN BUNDESTAG SINCE DECEMBER 1990 SERVING AS FEDERAL MINISTER FOR WOMEN AND YOUTH, FEDERAL MINISTER FOR THE ENVIRONMENT, NATURE CONSERVATION AND NUCLEAR SAFETY, GENERAL SECRETARY OF THE CDU AND CHAIRWOMAN OF THE CDU IN GERMANY.



BERND BORNHORST IS CURRENTLY THE HEAD OF DEPARTMENT OF POLITICS AND GLOBAL ISSUES OF THE FUTURE AT MISEREOR. BERND BORNHORST STUDIED POLITICAL SCIENCE, SOCIOLOGY AND COMMUNICATION STUDIES AND GAINED HIS PHD WITH THE THESIS "CHANCES AND BARRIERS OF NON-GOVERNMENTAL DEVELOPMENT COOPERATION". BERND BORNHORST STARTED WORKING WITH MISEREOR IN 1989, SERVING FIRST AS A DESK OFFICER FOR ARGENTINA, PARAGUAY AND URUGUAY. BERND BORNHORST HAS BEEN A BOARD MEMBER OF THE ASSOCIATION OF GERMAN DEVELOPMENT AND HUMANITARIAN AID NGOS (VENRO) SINCE 2005. IN DECEMBER 2013 HE WAS ELECTED AS CHAIRMAN OF VENRO.

ERNST-CHRISTOPH STOLPER IS A GERMAN POLITICIAN AND ENVIRONMENTAL ACTIVIST WITH MORE THAN THREE DECADES EXPERIENCE IN THE FIELD OF SUSTAINABLE DEVELOPMENT, ENVIRONMENT, ECONOMICS, CLIMATE AND ENERGY. HE IS VICE PRESIDENT OF FRIENDS OF THE EARTH GERMANY AND MEMBER OF THE EXECUTIVE COMMITTEE OF FRIENDS OF THE EARTH EUROPE. PRIOR TO HIS ENGAGEMENT IN THE CIVIL SOCIETY SECTOR HE SERVED AS DIRECTOR GENERAL IN CHARGE OF SUSTAINABILITY, ENVIRONMENTAL AND CLIMATE POLITICS AS WELL AS STATE SECRETARY FOR ECONOMICS AND ENERGY IN STATE GOVERNMENTS.



LORI WALLACH IS DIRECTOR OF GLOBAL TRADE WATCH, A DIVISION OF THE WASHINGTON-DC BASED CONSUMER ORGANIZATION PUBLIC CITIZEN THAT WAS FOUNDED BY RALPH NADER IN 1972. FOR 25 YEARS WALLACH HAS PLAYED A PROMINENT ROLE IN THE U.S. AND INTERNATIONALLY IN THE DEBATE OVER THE TERMS OF GLOBALIZATION, PROMOTING THE PUBLIC INTEREST IN THE U.S. CONGRESS AND FOREIGN PARLIAMENTS, THE COURTS, GOVERNMENT AGENCIES, THE MEDIA, AND THE STREETS. WALLACH, A GRADUATE OF HARVARD LAW SCHOOL, PREVIOUSLY WORKED FOR A DEMOCRATIC CONGRESSMAN, ON ELECTORAL CAMPAIGNS, AND IN TELEVISION NEWS.

WINNIE BYANYIMA IS EXECUTIVE DIRECTOR OF OXFAM INTERNATIONAL. SHE IS A LEADER ON WOMEN’S RIGHTS, DEMOCRATIC GOVERNANCE AND PEACE BUILDING. SHE SERVED ELEVEN YEARS IN THE UGANDAN PARLIAMENT, AND HAS SERVED AT THE AFRICAN UNION COMMISSION AND AS DIRECTOR OF GENDER AND DEVELOPMENT AT THE UNITED NATIONS DEVELOPMENT PROGRAM. SHE CO-FOUNDED THE 60-MEMBER GLOBAL GENDER AND CLIMATE ALLIANCE AND CHAIRED A UN TASK FORCE ON GENDER ASPECTS OF THE MILLENNIUM DEVELOPMENT GOALS, AND ON CLIMATE CHANGE.
